**LDV (Limited Dollar Value)** – Warranties provide a fixed dollar amount per square foot for roofing material

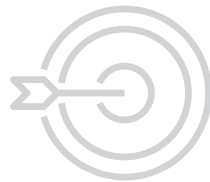
**LICV – (Limited Installed Contract Value)** – Warranties provide a dollar amount limited to the installed contract value for labor and materials
